***Treating wasp/hornet nests is dangerous work and should be left to professionals. It is advised that all nonqualified people along with their pets should stay away from these areas before, during and until the issue(s) is/are resolved. Wasp and hornet stings should be taken seriously and may require medical treatment.***

Upon arrival at your location, we inspect your wasp/hornet issue(s). The starting rate for one lower-level issue is \$250 plus tax without extenuating circumstances. Additional or more complex wasp/hornet issue(s) or higher-level issue(s) are at additional expense. We do not treat honeybees and advise you not to treat either as they are an integral part of our ecosystem. Beekeepers are listed on DEC website.

A1 No Nonsense Pest Control uses a combination of aerosols, dusts, liquids and/or glue boards, etc. to properly treat your issue(s). Some products may take longer to have full effect due to the nature of the control. Therefore, 100 percent control does not take place immediately in all situations. There is no guarantee that a one-time treatment will eliminate the infestation. Some situations need multiple treatments which are included in the cost. We share any conducive conditions with customers and offer a site-specific 3-month warranty to the compliant customers/tenants who address our concerns. In some cases, we utilize glue boards to catch stray wasps or hornets returning to the nest/hive. These are only temporary measures. They might fill up or they might fall. That's OK. Residents' cooperation is essential to eliminate or reduce wasp/hornet population. The homeowner/resident should not use any products themselves as this may compromise treatment and will void warranty.

In the event wasps are actively flying inside the residence, have damaged the wall or ceiling or we suspect they might, we examine the interior and determine if any additional action needs to be taken inside. Sometimes it makes sense to drill holes in walls or ceiling and to inject dust into it to treat the wasps. We then normally just cover the opening with caulk. If the wall or ceiling has been compromised by the wasps, we offer to cut sheetrock open, remove the wasp nest and insert an access panel cover at an additional cost. This can be a messy process, and we will do our best to minimize debris, but the resident will most likely need to perform additional cleanup. If the homeowner/resident wants to repair the wall void they can do so at their own expense. A1 No Nonsense Pest Control does not perform any sheetrock repair. In some cases, we treat the nest but do not remove it if it's inaccessible.

When treating wasp or hornet nests in bushes or trees or inground we may damage the vegetation, mulch and/or grass in treating and removing the nest. The homeowner/resident understands this and wants to proceed with treatment and waives the right to seek compensation for damages. In some cases, we will treat one day and may come back another day to remove the treated nest.

Wasp/hornet treatment involves the use of chemicals and in some cases, treatment may result in property staining even when applied in accordance with manufacturers' guidelines. The property owner/resident understands this and notwithstanding the risk of staining wants to proceed with treatment and waives the right to seek damages for staining and/or damages caused by moving of furniture/appliances that may arise from treatment.
