**Wild Animal Trapping**

Trap set up and final removal: \$270.31\* (includes 8.125% sales tax for Orange & Dutchess Counties & 8% for Ulster County)

Pick up of animals in traps: \$91.91 (\$108.13 for skunks) \* **PER PICK UP** (includes 8.125% sales tax for Orange & Dutchess Counties & 8% for Ulster County)

Removal of animals caught with your own personal trap will be charged \$162.19 (includes 8.125% sales tax for Orange & Dutchess Counties & 8% for Ulster County)

For every trapped animal pick up, there will be an \$91.91 (\$108.13 for skunks) charge for each pick up whether the animal is taken or released. (Even if the animal is not the desired target to be caught, you will still be charged to pick it up or release it and rebait the trap.) Payment is due upon pick up of animal.

Customers are responsible for checking traps every day, and calling the office daily to let us know of any changes (i.e., if the traps are set off, but no animal was caught or if there is an animal in any of the traps.) Up to three traps will be placed for up to one month. Trap setup and removal fee is nonrefundable regardless of noncapture of target animal. A1 No Nonsense Pest Control does not give any customers, their neighbors or anyone else permission to move or transport cages. It is illegal for unauthorized people to transport and/or release animals on any other property. New York DEC fines range up to \$1500 for such offenses. Customer is responsible for the return of traps in working condition (\$100/trap).

Please remember that trapped animals can be very dangerous and/or possess deadly viruses or diseases. Gloves should always be used in handling cages. Please ensure that all household pets and children are kept away from traps.

**DO NOT LET CHILDREN NEAR ANY WILD ANIMALS IN TRAPS**

\*Customers that have one of our yearly service plans will have 50% taken off their setup charges.
